CORONAVIRUS/COVID-19
ACTIVITY PARTICIPATION ASSUMPTION OF RISK, RELEASE,
WAIVER, AND DISCHARGE

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. It is believed that an asymptomatic individual can be infected with and transmit COVID-19 without their knowledge.

During the Amish Country Spring Home & Garden Show ("ACSHGS") event, JW Promotions ("JWP") will put in place preventative measures recommended by the State of Ohio to reduce the spread of COVID-19, however, JWP cannot guarantee that you or anyone else in your exhibiting group will not become exposed to or infected with COVID-19 as a result of participating in the Amish Country Spring Home & Garden Show ("ACSHGS") event. Participation in the ACSHGS event could increase the risk of contracting COVID-19.

NOW, THEREFORE, in consideration of being permitted to participate in events offered by JWP, I understand, acknowledge and agree to the following:

I have independently evaluated and reviewed the risks of being exposed to or infected with COVID-19 and have determined to participate in the ACSHGS events with full knowledge and acceptance of the risk. Fully understanding these risks, I, for myself, my child(ren), my spouse, my legal representatives, heirs and assigns hereby agree to assume full responsibility and liability for the risk of bodily injury, illness, permanent disability, and/or death which may result from exposure to or infection with COVID-19 before, during, or after participating in the ACSHGS event.

I, for myself, my child(ren), my spouse, my legal representatives, heirs and assigns, hereby waive, release, and discharge JWP, its officials, employees, volunteers, attorneys, and agents from any and all liability to me, my child(ren), my spouse, my legal representatives, heirs, and assigns, for any and all losses or damages resulting from bodily injury, illness, permanent disability, and/or death, whether caused by negligence of JWP or its officials, employees, volunteers, attorneys, and agents or otherwise, which claims, losses, and demands arise during or result directly or indirectly from exposure to or infection with COVID-19 before, during, or after participating in the ACSHGS event.

I acknowledge that all of my employees, legal representatives, or any other persons I cause to attend the event, have agreed to the above release of liability against JWP, and I agree to indemnify, defend, and hold harmless JWP from and against any and all costs, expenses, damages claims, lawsuits, judgments, losses and/or liabilities (including attorney fees) arising directly or indirectly from my employees, legal representative, or persons I caused to attend the event, to any and all claims made or against JWP due to bodily injury, death, loss of use, monetary loss, or any other injury specifically related to COVID-19.

I also acknowledge that in the event the State or local health department issues a mandatory "Stay at Home" order, or mandates the closure of certain programs and/or facilities, participant(s) will be entitled to a partial credit at the discretion of JWP. Refunds will NOT be issued.
